Universal natural language understanding

[semantics, computational linguistics]

- PROJECT OVERVIEW: This Research Council of Norway-funded project aims to develop and implement a rule-based semantic interpretation system, built on the language-agnostic Universal Dependencies syntactic framework, and using Glue Semantics as the syntax-semantics interface. We are building a highly modular system, where the core predicate-argument analysis relies solely on information available from the UD parse, and can therefore be applied to any language for which a UD parser exists. Additional language-specific resources (such as valency lexica or word-sense databases) can then be used in addition if they exist, but are not required.
 - MY ROLE: I am a post-doctoral researcher on this project, working under the P.I. Dag T. T. Haug. I am jointly responsible with the P.I. for developing the rules used in translating the syntactic parse into semantic resources, and for managing and training annotators who we use to generate gold-standard data from existing UD corpora. I also work on developing theoretical insights about the syntax-semantics interface from our experience with implementing analyses of a wide range of phenomena.
 - OUTPUTS: The project pipeline is presented in [15]. We have also produced a corpus of naturally-ocurring texts with semantic annotations, called DRASTIC [14]. Our more theoretical outputs include a paper exploring the inadequacies of existing quasi-semantic extensions to UD [18], one developing a new theoretical approach to handling scope islands in Glue Semantics and LFG [17], and one introducing a syntax-semantics interface for Dependency Grammar [16].

Multiword expressions and the lexicon

[syntax, semantics]

- PROJECT OVERVIEW: This was my D.Phil. project, funded by the UK Arts and Humanities Research Council. My thesis [1] gives an analysis of multiword expressions (MWEs), especially idioms. It argues against approaches which conceive of idioms like *spill the beans* as being made up of special versions of *spill* and *beans*, and in favour of approaches which reaffirm the mixed nature of MWEs as partially word-like and partially phrase-like. It then develops a concrete example of the latter kind of theory, integrating insights from Tree-Adjoining Grammar into the Lexical Functional Grammar architecture.
 - MY ROLE: I was solely responsible for this project from conception to completion, under the supervision of my D.Phil. supervisors, Ash Asudeh and Mary Dalrymple. I developed the research proposal, disseminated the work through presentations and publications, and successfully applied for additional research funding, including for a research visit to Germany.
 - OUTPUTS: I have presented this work at peer-reviewed conferences for computational linguists [47], theoretical syntacticians [45], and for more general linguistics audiences [43]. The work has also appeared in the proceedings of two of these conferences [20], [21]. I organised a collaboration with researchers at the Goethe-Universität Frankfurt am Main, where I conducted a research visit in June 2018. This resulted in a series of presentations and an ongoing research collaboration [4], [28], [40], [41], [54]. My formal proposals for integrating LFG and TAG appear in a chapter in the *Handbook of Lexical Functional Grammar* [7], and the theoretical import of this for LFG (viewed as a formalisation of Construction Grammar) is discussed in a paper in the *Journal of Language Modelling* [6].

Teaching

At the undergraduate level, I have created and (co-)led courses in **general linguistics**, **syntax**, **semantics & pragmatics**, **sociolinguistics**, **psycholinguistics**, and **historical linguistics**.

At the graduate level, I have created and led courses in **syntax** and **formal approaches to sociolinguistic variation**, as well as TA-ing for courses in **syntax**, **phonology**, and **formal foundations of linguistics** (an introduction to set theory, logic, and formal language theory for linguists).

My teaching experience covers small group and tutorial settings, larger classes, and lectures, and includes both curriculum development and the setting & marking of exams.
